Time Study Update

Hello New Mexico HCBS Providers,

As you know New Mexico Department of Health, Developmental Disabilities Supports Division (DDSD), has contracted with Public Consulting Group, Inc. (PCG) to perform a study to recommend reimbursement rates for individuals with intellectual and developmental disabilities receiving services through the Developmental Disabilities (DD), Mi Via (MV), and Medically Fragile (MF) waiver programs.

This communication provides information on the time study approach, training, and timeline.

Time Study Details

Based on information gathered during last week's focus group sessions, the time study tools and approach have been restructured. Below is a breakdown of the time study tools, including who should complete them and when the training will occur.

We will be providing a separate training session for each tool, which will all be live webinars. A recorded version of the trainings will be emailed and posted for future reference for anyone that was not able to attend one of the webinars. Tools and instructions will be provided prior to the training sessions.

Participation

100% participation is not required for the time study. We are requesting 60% participation of staff for each discipline. If you have 50 Occupational Therapists, we would need information from 60% (30) of the OTs. If there are also 50 Occupational Therapist Assistants (OTA), we would need information from 30 OTAs. If there is concern over meeting the 60% threshold, we encourage providers to oversample in case some staff are unable to complete the entire survey. Additional guidance on this sampling methodology will be provided in the instructions.
