What is the Vaccines for Children (VFC) Program?



The VFC Program is a federally-funded program that provides vaccines at no cost for children who might not otherwise be vaccinated because of an inability to pay.

The goal of the VFC Program is to protect against vaccine-preventable diseases by removing or reducing cost barriers to vaccination. Through a combination of federal and state funding, enrolled providers receive vaccines at no cost.

VFC providers can order all childhood vaccines recommended by the Advisory Committee on Immunization Practices (ACIP).

The public health objective of the VFC Program is to ensure a seamless vaccine distribution system and easy access to all recommended childhood vaccines.

How does VFC work?

The Centers for Disease Control (CDC) contracts with vaccine manufacturers to buy vaccines at reduced rates. **Enrolled providers order vaccines through the VFC Program and receive all the routine childhood vaccines at no cost.**

Who can be a VFC Provider?

New Mexico providers who have a current medical license with prescription-writing privileges may enroll. Once your application is approved, VFC staff will visit the practice, review and verify the practice's ability to comply with program requirements, and ensure that key staff are trained and that the practice or clinic is certified to store and manage VFC vaccines.

VFC Program Requirements

Requirements for participation include:

- VFC providers (except specialty clinics) agree to provide all age-appropriate ACIP-recommended vaccines to children in New Mexico
- Partner with the VFC Program to ensure that program requirements are met, and to protect the integrity of the program, patients, and vaccines, including annual recertification
- VFC providers agree to the proper storage and handling of vaccine, including:
 - ✓ Utilizing VFC-approved refrigerators and freezers
 - ✓ Using data loggers to monitor vaccine temperature
 - ✓ Storing, counting, managing, and administering VFC and state-provided vaccine separately and appropriately
- Participate in scheduled compliance visits and unannounced storage and handling visits
- Reconcile vaccine inventory monthly
